DESCRIPTION OF WORK: The Work shall be completed under one Contract and consists of all labor, skill, and materials required to properly construct the Project. The Project generally consists of the following primary components: Installation of 2,500 ft of 12" PVC pipe, 1,300 ft of 10" PVC pipe along 8800 W from 3100 S to 2600 S, and various lateral connections along the extent of the waterline as shown in the Project Drawings.

PRE-BID CONFERENCE: A Pre-Bid Conference will be held for all prospective Bidders at the 8885 West 3500 South, Magna, UT, 84044, followed by a project site walk-through, on Wednesday, February 11th, 2025 at 10:30 AM, at which time the Owner's Representative, Bidders, and Subcontractors will discuss the project. No Bid will be read or considered which does not fully comply with the above provisions as to bond and license.

The Work shall be substantially completed by 120 days after the Contractor commences work on the project and finally completed by 150 days after the Contractor commences work on the project. Substantial completion and final completion shall not happen later than 10/1/2025 and 11/1/2025 respectively.
