# BOWEN COLLINS AND ASSOCIATES TASK ORDER ADMENDMENT

### Amendment No. 1

# TASK ORDER NO. <u>19-03.01</u> ("2019 Secondary Waterline") PROJECT NO. <u>483-19-01</u>

# Additional Design Coordination and Services During Construction for 2019 Secondary Waterline Project

This task order amendment is issued by <u>Magna Water District</u> ("OWNER") pursuant to the General Services Agreement between the ("OWNER") and Bowen, Collins & Associates, Inc. ("ENGINEER") <u>February 3, 2016</u>.

### 1. SERVICES

This amendment request addresses an extension of BC&A's original contract to continue to support Magna Water District with Services During Construction of the 2019 Secondary Waterline Project. BC&A's original contract did not include SDC because the extent and duration of the construction period was not known prior to completion of the design phase.

This amendment also includes a request for additional compensation for coordination and design efforts required to accommodate the ongoing development design for the 201 Logistics Center and pipeline alignment along the future 7600 West.

Explanation: BC&A's original hourly fee estimate assumed that the pipeline would be designed within an open alignment and did not anticipate the additional coordination that has been necessary to accommodate design of the new roadway and development. As this coordination work developed over the past two years, BC&A has attempted as much as possible to stretch our existing budget and rates to accommodate this extension in project duration and level of coordination required to accommodate the development. In addition, we were able to extend our budget with the use of the Corps of Engineers wetland permitting task budget which was not required. Even with these efforts, BC&A's budget for the first phase of the project has been exceeded. We estimate that over \$19K in additional cost has been expended to coordinate with the 201 Logistics Center development over the duration of this project. As of the end of the design period, BC&A's budget has been exceeded by approximately \$8,078. We are proposing a request to only cover actual costs to accommodate these efforts to support the project.

### **Task 1 Request – Services During Construction**

Services during construction are anticipated to include the following scope:

BC&A will provide services during construction for the project including attendance at a pre-construction meeting, review and recommendation of submittals, pay requests, RFI's, and change orders, attendance at 24 weekly progress meetings, and development of

record drawings and project closeout documents. Construction management and field inspections will be provided by BC&A's Project Representative at an assumed 40 hours per week for the first 4 weeks as the project gets underway, then tapering to an estimate of 20 hours per week for the remaining 20 weeks. BC&A's Project Engineer will provide engineering services during the construction period at an assumed average of 8 hours per week for 24 weeks.

Adjustments to these assumed periods will be addressed with MWD in advance if the construction period requires a higher level of effort or extends beyond the assumed 24-week period.

### **Project Deliverables.**

- 1. Meeting notes from all construction meetings,
- 2. Construction period reviews and documentation (Submittals, PR's, RFI's, CO's),
- 3. Punch list walkthrough and final closeout documentation,
- 4. Record drawings.

### **Budget.**

**\$131,580.** Fee estimates for budgeting, and scope assumptions regarding each, are provided in the attached fee estimate.

### Task 2 Request – Additional Engineering Design Coordination Services

Additional engineering design and coordination services were required to accommodate the proposed 201 Logistics Center development. These services included coordination with Kennecott, the developer (DLM), the developer's engineer (Dominion Engineering), and the developer's contractor (Layton Construction) as required for design of MWD's new secondary waterline alignment and profile along 7600 West. Additional coordination efforts included multiple meetings, plan reviews, coordination and troubleshooting of CAD files provided by the developer, design iterations required to coordinate the pipeline profile with changes in the final grade of the 7600 West road surface, and periods of delay in BC&A's design effort that were required to accommodate the progress of the developer's design and to obtain approval of our alignment from Kennecott/Dominion Engineering. This task also includes additional design coordination with Salt Lake County for the 2550 South Road project that was constructed along the north side of the Riter Canal during the design phase of this project. That included coordination, plan review, and CAD incorporation of their design roadway surface.

### **Budget.**

**\$8,078.** The attached fee schedule includes a breakdown of the proposed additional costs including a credit for the permitting work under BC&A's original contract that was not used.

### 2. COMPENSATION

Refer to Attachment A for man hour fee estimate. Compensation is based on a time and materials basis. The project's task order not to exceed contract limit will be changed as indicated below:


